

McNay Art Museum Car Raffle Rules:

1. **TO ENTER.** From November 17, 2018 through May 19, 2019 at 5:00 PM. (CST), (“Entry Period”), entrants may enter the McNay Art Museum Car Raffle (“Raffle”) by purchasing a raffle ticket from an authorized employee or agent of the McNay Art Museum for \$10 each or four tickets for \$20, payable to the McNay Art Museum. Tickets may also be purchased over the internet at: www.mcnayart.org.

NOTE: DEADLINE TO PURCHASE TICKETS ONLINE IS Thursday, May 16, 2019 at 11:59 pm CST.

OFFICIAL DRAWING. The official drawing will take place on May 19, 2019 at approximately 5:30 PM at McNay Art Museum: 6000 N New Braunfels, TX 78209.

2. **SPONSOR.** The Raffle is sponsored by the McNay Art Museum, a Texas non-profit corporation (“Sponsor”). All decisions of the Sponsor are final.

3. **CONDITIONS.** An eligible entrant may only enter via the ticket purchasing methods as described above. Incomplete entries are void. By entering, entrants acknowledge compliance with these official rules including all eligibility requirements. All entries become the property of the Sponsor and will not be returned. Neither Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles, or reproductions of entries will be accepted.

4. **DETERMINATION OF WINNER.** A random drawing will be conducted on May 19, 2019 from among all eligible entries received. Odds of winning depend upon the number of eligible entries received. The winner will be notified by telephone, mail, and/or email. The winner will be required to complete an affidavit of eligibility and release, which must be completed and returned within five (5) business days of issuance of notification or an alternate winner will be selected. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by the Sponsor or its agents. **TICKETS (PRIZE) ARE NON-TRANSFERABLE AND CANNOT BE SOLD.**

5. **PRIZE.** The winner will receive a 1953 Chrysler New Yorker Taxi as their prize.

6. **ELIGIBILITY.** The Raffle is open to legal residents of the State of Texas, United States, who are physically located in the State of Texas, United States. The Raffle is void where prohibited. Employees and Directors of the Sponsor and their immediate families are not eligible to win the grand prize. Immediate family is defined as, through either blood or marriage, one degree of familial relationship (including in-laws and step-family), such as your spouse, your siblings, your parents, and your children. Immediate family does not include other family members (including in-laws and step-family), such as grandchildren, grandparents, nieces, or nephews.

9. **TAXES.** All applicable federal, state, and local tax associated with winning the prize in the Raffle will be the sole responsibility of the winner. The winner shall be provided a W2-G form for income tax purposes because the value of the prize exceeds \$600.

10. **LIMITATIONS ON LIABILITY AND DISCLAIMERS.** Sponsor, its employees, and its Directors, will not be responsible for or liable to any prize winner, winner’s family, or estate for any submissions of entries that are lost, late, illegible, damaged, incomplete, or incorrect. Sponsor can, at any time it

If the Raffle is canceled, all monies paid for raffle tickets will be returned to entrants. Decisions of the Sponsor related to the winner, interpretation of official rules, and other matters related to this Raffle are final.

Sponsor reserves the right to verify eligibility qualifications of the winner. Purchased tickets are not tax deductible nor considered a donation to the Sponsor. Winners and guests must demonstrate appropriate and respectful behavior during the race event, inappropriate behavior may result in forfeiture of prize.
